LINEAS' ENERGY SURCHARGE WILL OFFSET UNFORESEEN EXTRA COST AND BE ADJUSTED MONTHLY TO REFLECT CURRENT ENERGY PRICE

Lineas energy surcharge mechanism



Lineas mainly **operates** in **4 countries** (BE, DE, FR and the NL).
The cost and purchasing situation of energy in these countries varies considerably.



Lineas is implementing a model that reflects the **additional cost per country** for domestic traffic (start and end of a transport are in the same country).



For **international traffic**, Lineas is using a basket which is based on the share of energy consumption in the different countries.



The reference base for the surcharge is the **electricity price** for the next month, published on the 25th of every month at the EEX Future market.



For each country, the respective **future price applies** (e.g. for Belgium it is the "EEX Belgian Power Futures").
