The index level is calculated the month before the start of the upcoming quarter by taking the average between the 25th day of that month and the 26th day of the previous month. This to ensure that a possible surcharge is known a few days before the start of the upcoming quarter. The indexes used are the EPEX Spot for electricity and the Brent Crude Oil (front month futures) for diesel, which can be consulted on many different platforms.
