Lineas energy surcharge mechanism 2023



Lineas' energy surcharge offsets extra cost and is adjusted monthly to reflect current energy cost

- Lineas mainly operates in 4 countries (BE, DE, FR, NL). Cost and purchasing situation of energy varies.
- Lineas' model reflects additional cost per country for domestic traffic.
- For international traffic, Lineas is using a basket which is based on the share of energy consumption.
- Base is the electricity price for the next month, published on 25th per month at EEX Future market*
- For each country, the future price applies (e.g. BE = "EEX Belgian Power Futures").
- This model is being changed to a cost-per-line model in October 2023 (Intermodal) and January 2024 (all traffics) -- see next page

Changes 2023

- We need to charge base surcharge if market price falls below 100 Euro/ MWh as we had to log in to energy contract at higher prices (hedging).
- France and Germany have passed legislation to support companies that suffer from high energy cost. These potential subventions are reflected in our surcharge grids.
- Surcharge grids as of February 2023 have been adjusted accordingly and include government aid.

Lineas energy surcharge mechanism 2023/2024

Lineas' energy surcharge offsets extra cost and moves to a calculation per line

- New model: we calculate the real energy cost per line, surcharge value covers cost above 100 Euro per MWh
- Unit of measurement can be container, train or wagon
- We adjust the values based on our purchasing conditions incl. market prices once per quarter
- Values will be published on our homepage (lineas.net) under document library
- We do not publish a value per country anymore
- The new model is introduced in October 2023 for Intermodal and in January 2024 for all traffics
- For conventional traffics the known model remains valid until December 2023



Changes 2023/24

- We move away from a weighted basket for our traffics which distributed the extra cost over our network
- The (extra) cost of energy is identified per line and surcharge values calculated per line
- This means that lines with low energy cost will see a decrease in energy surcharge, while lines with high energy cost will see an increase in energy surcharge
- The purchasing conditions are currently negotiated and we expect an overall lower level of energy cost for 2024 which will bring the average surcharge significantly down vs. 2023

October 1st, 2023

For Intermodal, we move to a calculation line-by-line as a basket is not reflecting the real cost sufficiently anymore.
